If any portion of this agreement is unenforceable, the remaining portions shall remain in full force and effect. Under no circumstances shall Hidden Creek Vineyard & Winery Inc. be liable to any vendor / demonstrator for any costs attached to displaying their arts / crafts in a free event. Upon acceptance of my application, this agreement shall be deemed to have been entered into at Laceyville, Pennsylvania and shall be construed according to the laws of the State of Pennsylvania.
